Crew

Apart from the members of the band, the organizer is to expect the band to bring **2 crew members** along for the show. Any restrictions on this matter will be agreed upon in the contract prior to the show.


The band is obligated to contact the organizer in case they bring their own Front of House and/or Lighting Engineer. In case Black Oak County doesn't mention this in the correspondence with the organizer, we expect the organizer to hire and present a Front of House and Lighting engineer for the soundcheck and show.

Please note that the position of the backing vocals and Lead Vocals 2 might be flipped.

Drum riser

The organizer must provide a drum riser, measuring a bare minimum of 200 cm wide by 200 cm deep, with a minimum height of 40 cm. In case the drum riser won't live up to these requirements, please contact the band immediately.

Monitors

The band requires 4 separate monitor sends, one for each monitor provided on the table above. Please note in-ear monitors might be used for the show, please contact us ahead of time in case you need to have this cleared with us.

Power

The symbol is meant to symbolize electrical outlets. At these locations there must be a minimum of 3 separate electrical sockets for pedalboards, etc. The electrical sockets must be regular European 230v outlets. In case the stage runs on a current other than 230v, the organizer must provide the band with converters, or contact the band immediately.

Confetti & CO2 Jets

In case these are available at the bands preferred rental supplier, Black Oak County will bring confetti launchers and CO2 jets for their stage performance. In case the organizer has any objections on the matter, or if the organizer already provides these on-site, please contact the band immediately. In case the organizer is able to provide these for us, please let us know.

Gear

Black Oak County will bring the following gear for the show in question.

Drums

In the case of festival performances with a tight change-over, one-off gigs and fly dates, Black Oak County needs the organizer to provide them with a complete drum-kit, consisting of the following:

1x bass drum (min 22" preferede 24") 1x 13 Tom 1x 16 Tom with legs 4 cymbal stands (min 2 boom) Hi-hat stand two legs (prefered DW 9000) DW 9000 double bass pedal Drum stool Hi-hat (14" Zildjian A-Custom) Paiste 2002 18" Crash Paiste 2002 Black label 20" crash Paiste 2002 22" ride Paiste Signature 18" crash

If a rental kit is provided, the band will still bring their own Snare, Hi-Hat, Cymbals and Drum stool if possible. Please reach out to us with the specs for the rental kit at least 14 days ahead of the show.

If not provided by a rental-kit, the band brings their own drum kit consisting of the following for their given performance:

24" DW Kick
16" DW Floor Tom
13" DW Tom
14" Snare
1 x Hi-hat
2 x Crash cymbals
1 x Ride cymbal
1 x Drum stool

Amplifiers

Black Oak County brings the following amps to the show:

2 x Line6 Helix multi-effects amp simulators

1 x Line6 HX Stomp multi-effects amp simulator

3 x Harley Benton power amps, for guitar cabinet amplification (stage monitoring only)

As the band uses digital amp modeling technology to achieve their sound, no mics on the guitar cabinets are required. **The on-stage guitar cabinets are for on-stage monitoring only.** A direct signal will be sent to the Front of House via a XLR-cable, straight from the modelers.

In order to prevent grounding problems, the organizer must provide D.I.'s to these digital modelers. The D.I.'s should be placed by the pedalboards at the stage edge.

Hospitality Rider

Allergies

Due to allergies within the band and crew, there must be a minimum of 1 serving of food, which does not contain neither poultry, eggs nor carrots. Failure to comply will result in anaphylactic shock!

1 vegan/vegetarian serving would be preferred as well, however if not available, the band member will eat whatever is available.

Backstage accommodation

Black Oak County has the following list of demands regarding the backstage accommodation. The accommodation should be available to the band no later than 2 hours pior to the show, and the curfew of said accommodation can not be set to earlier than 2 hours after the show.

The accommodations must include:

- Electrical outlets for charging of phones, video equipment, etc.
- Seating for a minimum of 6 people, in the form of tables, chairs and preferably a couch
- A half-body sized mirror
- A minimum of 6 towels (small, for the stage) and 4 bath towels
- Access to private toilet facilities
- Snacks: fruits, candy bars, crisps/chips or similar
- A drinks selection, containing a bare minimum of:
 - Fresh coffee, with available cream and sugar
 - 24 bottles of still water, non-carbonated
 - 24 bottles of beer
 - 24 bottles of mixed soft drinks, preferably Coca Cola, Coca Cola Zero, Fanta, Mountain Dew or similar brands
 - 1 bottle of gin
 - Lemon soda for drinks mixing
 - Icecubes
 - Plastic or paper cups

In case any of the above stated requirements can't be met, contact the band immediately.

Accommodation - Hotels

Black Oak County requires hotel accommodations paid in full by the organizer as part of their performance. For these accommodations, the band requires a minimum of 4 single beds (up to 6, depending on the size of the traveling party). We kindly ask **not** to be lodged at hostels etc., where we need to share accommodations with other travelers.

Merchandise

Black Oak County will bring their own merchandise, including t-shirts, CD's and vinyl, which should be put up for sale and on display by the organizer in a suitable, clearly visible area - preferably with personnel provided by the organizer to help us sell this merchandise.

In case there isn't a planned merchandise area by the organizer, the organizer is to provide one for the band, with a table of a minimum of 100×100 cm. All fees from the merch sales are to be paid by the organizer. If any disagreements should arise on the matter, please contact the band immediately.

As a rule of thumb, we only accept cash for merchandise sales during international shows. If the organizer accepts any payment on the band's behalf via credit card or other mobile solutions, the organizer is to pay out the amount in full to the band, prior to the band's departure from the venue/festival. In case any discrepancies might arise on this, please contact us immediately.
